

Following the political agreement, the Commission has begun a strategic planning process.

The result of the process will be set out in a multiannual Strategic Plan to prepare the content in the work programmes and calls for proposal for the first 4 years of Horizon Europe.

The strategic planning process will focus in particular on the Global Challenges and European Industrial Competitiveness pillar of Horizon Europe. It will also cover the Widening Participation and Strengthening the European Research Area part of the programme as well as relevant activities in other pillars.

Apply for a Grant

The STCU grant process consists of three main stages: Short form application, Full form application and the Project Agreement stage. Please review the "Typical STCU Project Lifecycle" for a simplified graphic view of the STCU Project Process.

Managing Your Project

The STCU does not manage projects. Rather it administrates and oversees projects on behalf of the funding parties. The responsibility of managing any given project lies entirely with the project manager. The Project Agreement, which consists of the main body of the agreement, the work plan (Annex I - supported by the schedule, personnel, and funding tables), the General Conditions (Annex II), and the Formats for Progress and Technical Reports (Annex III) outline the specific issues for which the project manager is responsible.

Private companies, industry organizations, government agencies and programs from Canada, European Union, and the USA can <u>apply for Partner Status</u>.

Project Documents & Forms

The new Erasmus+ programme aims to support actions in the fields of Education, Training, Youth and Sport for the period 2014-2020.

Erasmus+ replaces seven programmes bringing together

- the Lifelong Learning Programme (Erasmus, Leonardo da Vinci, Comenius, Jean Monnet and Grundtvig)
- the Youth in Action programme
- five international cooperation programmes (Erasmus Mundus, Tempus, Alfa, Edulink, the programme for cooperation with industrialised countries)
- the new sport action.

Erasmus + provides grants for a wide range of actions and activities in the fields of education, training, youth and sport. The programme gives opportunities to students, trainees, staff and volunteers to spend a period abroad to increase their skills and employability. It supports organisations to work in transnational partnership and to share innovative practices in the fields of education, training and youth. The new sport action will support grassroots projects and cross-border challenges such as combating match-fixing, doping, violence and racism.

The actions of the Erasmus + programme are divided into decentralised actions and centralised actions. The decentralised actions are managed in each programme country by National Agencies that are appointed by their national authorities. The



Ukraine

Cooperation between Germany and Ukraine in science, technology and innovation as well as in education has become an integral element of the two countries' strategies for international cooperation.

Cooperation with Ukraine is becoming increasingly important due to the recent political developments and the country's key role in the European Union's neighbourhood policy. Against this backdrop, the Federal Government has launched an Action Plan Ukraine under which it is supporting Ukraine's political, economic and societal reforms and stabilization, involving the participation of the Federal Research Ministry and other departments, implementing organizations and partner agencies.

Key Areas of Cooperation

The thematic focus of bilateral S&T cooperation with Ukraine is placed on the areas of:

- Biotechnology,
- Nanotechnology, novel materials and production technology,
- Health research and medical technology,
- Technologies for an efficient use of resources and energy, sustainable environmental technology.

The cooperation partners on the German side are the universities as well as the institutions of the Fraunhofer Society, the Helmholtz Association, the Max Planck Society and the Leibniz Association. The main Ukrainian partners are the institutes of Ukraine's National Academy of Sciences and the Ukrainian universities. Furthermore, more and more small and medium-sized enterprises are becoming involved on both sides.

A contact person for research cooperation is posted in Kiev to support the Federal Research Ministry. The contact person's responsibilities are to collect and assess information on Ukraine's potential for research and innovation and current developments, maintain cooperation ties with German and Ukrainian stakeholders at authorities and research institutions on the ground, advise German players and facilitate the realization of bilateral activities in Ukraine.

Next to bilateral cooperation between the Federal Research Ministry and Ukraine, the Federal Research Ministry is also represented by its Project Management Agency at the German Aerospace Center (International Bureau) in four projects at EU level:

To train Finance and Human Resources personnel on EU-adopted procedures and protocols
